
MANAGER'S CORNER

I hope you are all getting the chance to enjoy the warm temperatures by walking on the trail at the Park, playing a round of golf, basketball or pickleball. Speaking of the Park, Spring Grove Regional Parks and Recreation submitted a grant to DCNR for a dog agility area and an 8-12 year old playground. The grant awards will be determined in the Fall of 2023.

The Jackson Township Sewer Authority was reently awarded a grant in the amount of \$731,136 to go towards the construction of the Sprenkle Road Interceptor. Grants, such as this one help to keep user fees for the sewer stable. The cost of construction does not get passed to the users of the system, therefore saving the rate payers costly fees and increased rates. The Authority engineers are busy preparing the bid package for that project. The hope is to begin construction later this year or early next year.

The Municipal Building is undergoing a minor renovation. Northern York County Regional Police conducted a security study at the municipal offices that looked at lighting, signage, parking, and internal safety inside the building to include keyless entry and cameras. When you come to the building, the old front counter has been removed, and a wall has been installed. At the wall, there will be a "forms" center where you can pick up building permit forms, land use and zoning



applications, etc. Along the wall there will also be a countertop where you can fill out your forms. All payments can be made at the drop box (outside), or at the service window on your right as you walk into the vestibule. We are still renovating while I am writing this article so, please excuse our appearance in the front entrance. The Township is also installing decorative solar lights in the parking lot.

- Vacancies for the various Commissions and Boards were filled by the Supervisors with the following reappointments or appointments for 2023. Patrick Buhl, Township Sewage Enforcement Officer; Douglas Barmoy/Reg Baugher/Brandon Bischard, alternate Township Sewage Enforcement Officers; Brad Dunham, Township Fire Chief; Brian Bankert, Township Emergency Management Coordinator; David Jones (Stock and Leader), Township Solicitor; Jeff Shue (C.S. Davidson), Township Engineer, Florence Ford, Township Open Records Officer; Joseph Lange, Chairman of the Vacancy Board (1-year term); Joyce Sheridan, Sewer Authority (5-year term thru 2027); Diane King, Planning Commission (4-year term thru 2026); Travis Thoman, Zoning Hearing Board (3-year term thru 2025); Melinda Carlson, alternate on the Zoning Hearing Board (3-year term thru 2025).
- Authorization to award the only bid received for the Pavilion Sides for the Pavilion at the Little Creek Community Park was given to the York Tent and Awning Company in the amount of \$40,176.00. Funds will be used from the available ARPA funding.
- Authorization was approved for Township Officials to attend the Pennsylvania State Association of Township Supervisors Conference April 23 26, 2023 in Hershey PA.
- A public hearing and meeting was held February 7, 2023 at the Township Building to consider a Zoning Map Amendment for (2) parcels of land totaling approximately 7.428 acres from Industrial (I) to Medium-Density Residential (R-2) located at 5397 Lincoln Highway West.

Ordinance 228-2023 to amend the Zoning Map at 5397 Lincoln Highway West from I To R-2 was enacted.

- Authorization to award the only bid received for the Electronic Door Locks and Camera System for the Municipal Building located at 439 Roth's Church Road was given to the Global Data Consultants Company (GDC) in the amount of \$19,328.60. Funds will be used from the available ARPA funding.
- Manager Ford was nominated to the York Area Metropolitan Planning Organization (YAMPO) for a three year term through 2025.
- Resolution 01-23 Disposition of Certain Public Records was adopted.
- The Board authorized Chairman Holmes to sign the Easement Agreement with Jonathan D. & Lydia K. Stauffer for the Sprenkle Road Culvert Replacement Project.
- Authorization to award the bid and Notice to Proceed with the Sprenkle Road Culvert Replacement project was given to the DOLI Construction Corporation in the amount of \$483,194.57. Funds will be taken from the Liquid Fuels (State) account.
- Resolution 02-23 Funding Commitment Letter concerning application to the Department of Conservation and Natural Resources (DCNR) for Phase 1B Little Creek Park and authorizing Chairman Holmes to sign all documents pertaining to the grant was adopted.
- The resignation of Steve Hudgins as a member of the Sewer Authority was accepted with regret.
- Mark Derr was appointed to the Sewer Authority for the remainder of a term through 2025.

SUBDIVISION AND LAND DEVELOPMENT ACTIONS:

- Robin Hood 4111, Incorporated (Carman's Creamery) Final Land Development Plan located at 1109 Hanover Road was granted a waiver on the modification of roadways, a planning sewer exemption and given conditional approval.
- Martin's Potato Chips, Incorporated located at 5847 Lincoln Highway West Final Land Development Plan was granted a waiver for the addition of a storage pole barn.
- Trinity Excavation (3 Lot) Subdivision Plan located at 1101 Hanover Road was granted a waiver for curbing and sidewalk requirements and given conditional approval.

ZONING HEARING BOARD ACTIONS:

- Matthew Snyder of Carmen's Ice Cream was granted a Special Exception for an Ice Cream Parlor/Restaurant at 1109 Hanover Road.
- Moove In Partners was granted a Special Exception for Mini-Storage at 4846 West Market Street.
- William & Linda England was granted a Special Exception to operate an Event Venue at 5234 Lincoln Highway West. A Variance was granted for the parking requirements by securing an off site parking location with the use of valet parking.

Seven Ways to Be #StormwaterSmartPA

This issue of the Jackson Township Gazette will give you the Fifth and Sixth actions you can take to reduce stormwater runoff pollution at your residence and in your community. You'll find more specific guidance on residential property stormwater best management practices in "A Homeowner's Guide to Stormwater BMPs" located on our website www.jacksontwpyork.org under the "Quick Reference", "Stormwater Management" section.

The Pennsylvania Department of Environmental Protection would like to know if you have come up with ways to be stormwater smart in Pennsylvania. If so, they would love to hear your thoughts and suggestions and see your stormwater management photos on social media. Share using the hashtag #StormwaterSmartPA, and help them spread the word to reduce stormwater pollution in Pennsylvania.

5. Contact your local government

About 950 municipalities in Pennsylvania are required to have stormwater management plans, and most are also required to have Pollutant Reduction Plans. Contact your township or county office to find out their plans and how you can help implement them. Your interest will be welcomed. For example, municipalities are required to do public communications outreach to inform community residents about stormwater and may appreciate your help in organizing or publicizing an educational activity. You won't know how you can help or what programs you can benefit from until you contact your local government, so don't wait.

6. Calculate the stormwater runoff on your property to make informed building decisionsThe United States Environmental Protection Agency (EPA) offers a "stormwater calculator software tool" at epa.gov/water-research/national-stormwater-calculator that

calculator software tool" at epa.gov/water-research/national-stormwater-calculator that will estimate runoff at a location based on information such as soil type, landscape and land-use information, and weather. It may be useful to homeowners as well as to developers and landscape designers.


