## FROM THE ZONING OFFICER Ray Dietrich

Changes to the Jackson Township Chapter 50 Burning Open; Outdoor Fires Ordinance.

At the May 7th meeting the Board of Supervisors approved changes to Chapter 50 Open Burning.

The two major changes are as follows:

- 1. A permit is now required for any open burning. An application is to be submitted to the Township office at least 3 business days prior to igniting any open burn. The Fire Chief will review and either approve or deny the permit based on the current conditions he observes.
- There was also a change to the property line distance for a recreational fire from the previous 50' requirement. That distance was reduced to 25' from a property line.

## JACKSON TOWNSHIP SEWER AUTHORITY Matt Bollinger, Superintendent

Monday, **September 26, 2022**, The Wastewater Treatment Plant Operators will begin to clean and inspect sewer lines in the Route 30 area. Residents should expect cleaning and televising equipment along Route 30 and in the backyard right-of-way.

## **TOWNSHIP MEETING HIGHLIGHTS:**

- Authorization to award bids for Road Materials and Equipment Rental for 2022 road projects was given for the following: Crushed Aggregate (Stone) material – Vulcan Materials - \$48,850.00; Bituminous Paving (Asphalt) material
- York Materials Group \$158,800.00; Equipment Rental (Paving) H & H General Excavating \$30,870.00.
- The Board approved a \$20,000.00 contribution to the Northern York County Regional Police Department's Automatic License Plate Reader (ALPR) program. The funds will be paid out of the American Rescue Plan Act (ARPA) funds.
- The Board appointed Philip M. Sprenkle to the Agriculture Security Committee.
- Ordinance 225-2022 An Ordinance Amending Section 133-13 "High-Density Residential Zone" was enacted.
- Ordinance 226-2022 An Ordinance Amending Chapter 50 "Open Burning; Outdoor Fires" was enacted.
- The Board approved a bond reduction of \$13,663,482.55 Northpoint requested for the public improvements' security on the Final Land Development Plans for NP Briarwood, LLC that was posted for \$41,561,360.17. The bond balance after the reduction is \$27,897, 399.62.
- The Junkyard licenses were renewed for July 1, 2022 June 30, 2023 for the following locations: 329, 351 and 642 Jackson Square Road.
- The Board approved a donation of \$250.00 to the Northern York County Regional Police Department's National Night Out event held August 2, 2022 at the Dover Fire Company.

## **OFFICE OF JACKSON TOWNSHIP FIRE CHIEF**

#### WINTER FIRE SAFETY

Winter increases the potential for fires in our homes. Furnaces, woodstoves, fireplaces and other heating devices are operating to provide heat, more people are staying indoors and there is an increased electrical demand for lighting and the use of appliances. A simple checklist can increase your awareness of how fires occur and help you take simple precautions to prevent most fires and fire-related injuries.

#### WOOD STOVES AND FIREPLACES

Is your woodstove installed properly and in good condition?

Do you have 36" clearance from combustible surfaces and items and

Have proper floor support and protection?

Is your chimney inspected and cleaned annually?

Do you have a glass or metal screen covering the fireplace opening?

#### Safety Tips.....

Do not use flammable liquids to start or accelerate any fire.

Burn your stove hot twice daily to reduce creosote buildup in the chimney.

NEVER burn charcoal in your stove or fireplace and limit the use of paper to build a fire.

NEVER close your damper with hot ashes in the fireplace and be sure the fire is out before leaving the house or going to sleep.

#### **KEROSENE HEATERS**

Do you always use K1 kerosene and burn according to the manufacturer's directions?

Is the heater in a well-ventilated room?

Are all combustible materials at least 36" away from the heater?

Is the heater placed where it will not be knocked over or block an escape route?

#### Safety Tips.....

Use only approved heaters with an emergency shut off if the unit is tipped over.

NEVER fill a heater while it is hot and NEVER refuel a heater inside your home.

Keep fuel stored in approved metal cans outside the home.

Don't move a burning heater and know how to use the manual shut off in case of a flare –up.

Make sure the home is ventilated so carbon monoxide doesn't build up inside.

#### **FURNACE HEATING**

Are all controls and emergency shutoffs in proper working condition? Has the furnace been inspected/serviced by a professional? Are flue pipes well supported, free of holes, rust, and cracks?

#### Safety Tips.....

Make sure furnaces and chimneys are in good repair.

Keep trash and other combustibles away from heating systems.

#### **OTHER WINTER FIRE SAFETY TIPS.**

If there is a fire hydrant near your home you can assist the fire department by keeping the hydrant clear of snow and ice so in the event it is needed, it can be located.

Be sure every level of your home has a working smoke alarm, and be sure to check and clean it every month.

Carbon Monoxide detectors should be installed in every home to warn of deadly build-ups.

Never use a range or oven as a supplementary heating device. This is a safety hazard and can produce potentially deadly fumes.

NEVER try to thaw frozen water pipes with a blowtorch or other open flame. The pipe could conduct the heat and ignite a fire inside a wall. Use hot water or a UL labeled device such as a hair dryer for emergency thawing.

And finally...know how to contact the fire department for any safety concerns.


The Pennsylvania Department of Environmental Protection would like to know if you have come up with ways to be stormwater smart in Pennsylvania. If so, they would love to hear your thoughts and suggestions and see your stormwater management photos on social media. Share using the hashtag #StormwaterSmartPA, and help them spread the word to reduce stormwater pollution in Pennsylvania.

#### 1. Know the impaired streams near you

Visit the Pennsylvania stormwater GIS map site at www.depgis.state.pa.us/MS4/index.html. Select your county, then select your municipality, and then hit "click to view features". All the red lines are impaired streams. Click on the streams to see their names and causes of impairment. Then take steps to start making a difference.

#### 2. Plant a rain garden

Rain gardens are native plants set in a hole or trench in the ground to help rain water infiltrate into the ground. The Penn State Extension Office provides a great how-to on the basics of planting a rain garden at www.extension.psu.edu/rain-gardens-the-basics. The Audobon Society of Western Pennsylvania offers some rain garden designs at www. aswp.org/pages/rain-gardens.

- No construction debris will be collected curb side.
